**LOCAL GOVERNMENT ACT 2016, ACT 936**

The Nanumba North Municipal Assembly Rating Authority has approved the making and levying of the following rates for the fiscal year 1<sup>st</sup> January to 31<sup>st</sup> December, 2020.

**(A) RATES**

i. Basic Rates

A general basic rate of GH¢ 2.00 is payable by all male and female adults of or above 20 years who reside within the area of Authority of the Nanumba North Municipal Assembly and who is not in attendance at an educational institution and do not receive any remuneration or income during that period, other than an allowance, loan or other grant provided for purposes of education including any sum received by a person in respect of temporary employment undertaken by the person during vacation from an educational institution.

ii. Property/Special Rate

In addition to the general basic rate and property rate, special rates are payable per annum by all persons of or above the age of 19 years who reside in the area of Nanumba North Municipal Assembly and who own immovable properties as follows:

1. The notice constitutes the effective making and levying of such rates, fees, licences and rent as from the date of publication. It shall be the duty of every person liable to pay the amounts thereof at the offices of the assembly on or before 31<sup>st</sup> December, 2020 unless such a person has paid to a collector or other authorized persons.
2. Any person who without lawful justification or excuse, the proof of which shall be on him/her refuse or wilfully neglect to pay any levy payable by him/her on or before the date on which it is payable, shall be guilty of an offence and liable to summary conviction to a fine determined by a law court or imprisonment for a term not exceeding one year or both. Any person so convicted shall be ordered by the court to pay the levy.
